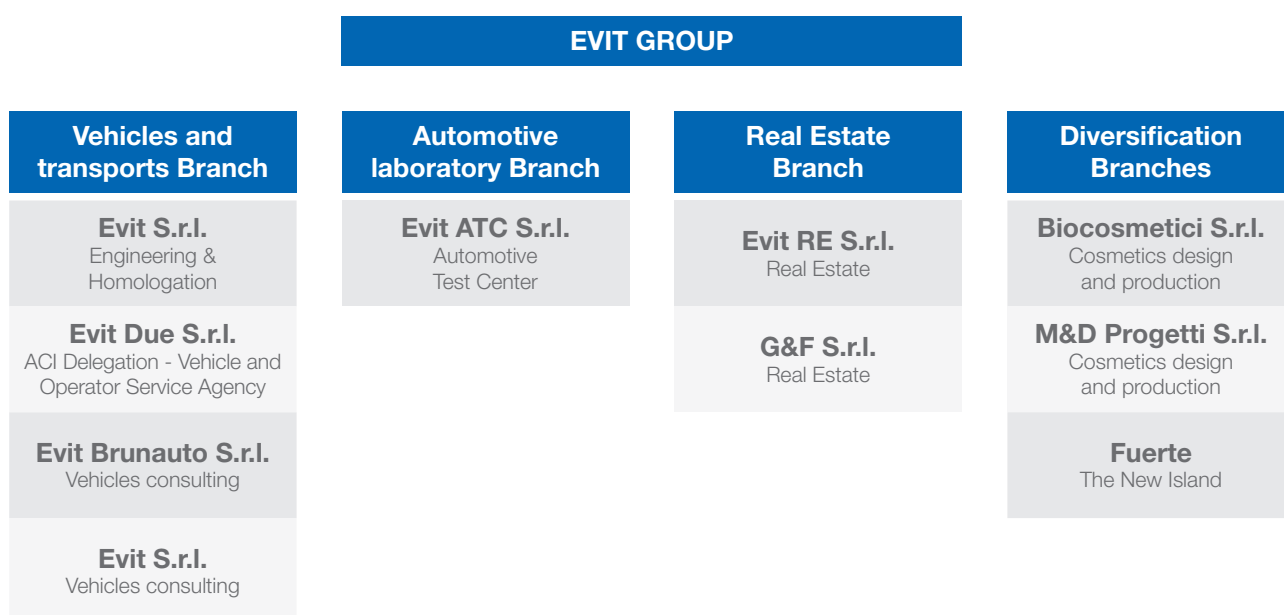
In estate sector there are **EVIT RE S.r.l.** that manages and develops real estate and **G&F S.r.l.** that deals with consulting in this sector.
